Early Childcare Educators of British Columbia (ECEBC) has named People Corporation as the official supplier of the ECEBC. The program will be **exclusive to ECEBC members** and will take advantage of our considerable buying power. We are pleased to report that many Franchisees are already taking advantage of the unique program that is designed to save you money on employee benefits programs – permanently.

Who will be Eligible?

- If you are a member of the ECEBC:
 - o **Full Member** Has an Early Childhood Educator's License to Practice from the Provincial Community Care Facilities Branch. Eligible to vote on provincial issues at ECEBC's Annual General Meeting.
 - o **Student Member** Is in the process of becoming professionally qualified in the field of early childhood or is in the process of completing 500 hours of work experience.
 - Associate Member Holds post-secondary certification in a related field or has been a full member of ECEBC and is now retired from the ECE field or is currently employed in the early childhood field and is in good standing with the Provincial Community Care Facilities Branch.

Note: Coverage cannot be purchased on an individual basis and must be initiated through a center.







Unique features of the ECEBC Group Benefits Program are:

- Low plan administration fees because of the large buying power of the Franchisee Plan. This means long term cost stability, as employees and their families may be able to claim more without it negatively impacting the cost of the program.
- Access to a Preferred Pharmacy Network which allows employees and their families to obtain prescription medications at a significant discount.
